**EP Condition 3.1 : Environmental Monitoring and Audit (EM&A) Requirements**

**Proposal of Change of Impact Monitoring Stations at Kowloon Animal Management Centre**

I refer to the Environmental Team Leader's letter dated 9 August 2024 (ref.: 403329/TC/sc/L-233) enclosing the Proposal of Change of Impact Monitoring Stations at Kowloon Animal Management Centre (KAMC) of AFCD (the Proposal) in accordance with Condition 3.1 of the EP No. EP-544/2017 for our approval as reproduced below :

**"EP Condition 3.1:**

*The EM&A programme shall be implemented in accordance with the procedures and requirements as set out in the EM&A Manual (Register No. AEIAR-204/2017) of the Project. Any major changes to the programme shall be justified by the ET Leader and verified by the IEC as conforming to the relevant requirements as set out in the EM&A Manual, and shall **seek the prior approval from the Director** before implementation.*

2. The Proposal proposed to relocate the existing construction dust and noise monitoring stations (AMS1-T and NMS1-T) at KAMC to alternative monitoring stations (AMS1-T2 and NMS1-T2) at Shing Kai Road Garden and 138 To Kwa Wan Road (as shown in Appendix 1) due to the relocation of KAMC and the existing monitoring stations will not be accessible. We also note that the Proposal has been duly justified and verified by ET Leader and IEC respectively.

3. Having reviewed the submission, we consider the Proposal of alternative monitoring stations as follow is acceptable:

4. The Proposal is hereby approved by the Director of Environmental Protection for fulfilling the above EP Condition from the environmental perspective as examined under the EIAO and does not absolve the project proponent and/or its work agent(s) from any requirements or obligations under other laws in force in Hong Kong, nor their liability due to any conflicts, nuisance or damages that proposed works may cause to third parties.

5. The Proposal will be available on the EIAO Register for public information. The Proposal shall be uploaded to the dedicated project website as set up under EP Condition 4.2. Besides, please clearly report the changes and the concerned justifications in the forthcoming EM&A report.
